Dear Town Resident:

The essential assets for a growing, progressive, community includes an attractive environment, strategic location, a stable tax base, a good transportation infrastructure, excellent protective and maintenance services, quality residential and commercial property, parks and recreation facilities, involved, caring residents and community leadership. We believe Lawrence has many of these assets available to advance our community to promote a "great place to live and work". The assets Lawrence possesses provide great incentives for people to locate their families and businesses here. Our current population is 5,286 and we will continue to be a leader in growth in Brown County.

We are again proposing a tax rate for 2019 with zero increase on your Town portion of the property tax bill. We've recently completed the creation of two Tax Incremental Financing Districts within the Town which will support new development and provide a financing source for the development of major infrastructure projects which will utilize future tax revenues from that same new development to fund the improvements.

The Town currently contracts with Advanced Disposal Services for weekly garbage and bi-weekly recycling pickup. The current contract for this service is set to expire at the end of 2018. As a result of a process to review and solicit competitive proposals, Advanced Disposal was the lowest cost proposal in the process and we are happy to announce that you should see no change in the current service, though at a considerable reduction in the costs of the service. You will see a reduction in the annual garbage/recycling assessment of more than \$30 as a result of the new contract.

Many of you who travel along Hickory Road in the Town know that the section closest to the Fox River and Lost Dauphin Road was recently upgraded as part of the Brown County Highway project for County Highway D. This project included the construction of a new roundabout at the CTH D intersection, and new alignment of Hickory to the railroad tracks. The Town has been working towards the design of a new road for the remaining portion of Hickory between Lawrence Drive and the railroad tracks. We are extremely happy to announce that we've been awarded a grant through the Wisconsin Department of Transportation Town Road Improvement-Discretionary Project program in the amount of \$458,548.06. This significant grant amount will provide state funding for half of the costs to upgrade/replace the remaining section of Hickory Road in spring 2019.

Quality protective services are a very significant asset for any community. The Lawrence Fire Department is a volunteer organization that includes 27 member volunteers along with 6 Medical First Responders that utilizes two fire stations located in North and South Lawrence with state of the art equipment. We are affiliated with the newly formed Fox River Fire District which encourages shared staff and equipment with neighboring communities.

Response to smoke/fire emergency calls has been greatly enhanced within the past year due to a relatively new program called AutoAid, through the Fox River Fire District. In the event of a confirmed smoke/fire incident, our Lawrence firefighters will respond as normal. In addition, and simultaneously, if the event occurs within the Town's fire hydrant area, units from three other neighboring communities will be dispatched to Lawrence as well: ladder truck from De Pere, engine from Hobart and an engine from Ashwaubenon, all with a crew of three firefighters and a chief/officer. This ensures that a minimum of 16 responders are dispatched to the call immediately, which meets a key ISO standard of 15 responders within 12 minutes. The Town recently achieved an enhanced ISO rating, due in part to this greatly advanced level of service, which directly relates to a decrease on property owner insurance costs. Though the AutoAid program operates in the Town's hydrant area, the ISO rating has improved significantly for all areas of the Town.

We contract ambulance services with De Pere. The Hobart-Lawrence Police Department (HLPD) was established in 2001. The Town of Lawrence and Village of Hobart established a cooperative department to provide the highest quality at the lowest cost to taxpayers. This group of dedicated professionals includes one full time Chief, one full time Lieutenant, and 8 Full-time police officers that includes a K-9 unit and a school liaison officer at Hemlock Creek Elementary School. Our protective services staff are actively involved in the community. We appreciate all of their contributions!

Town of Lawrence- Frequently Asked Questions

Q. Where does voting take place?

A. Voting on Election Day is held at the Town of Lawrence Town Hall located at 2400 Shady Court, De Pere, Wisconsin. The polls are open from 7:00am to 8:00pm.

Q. What school district do I live in?

A. There are two school districts in the Town of Lawrence. The West De Pere School District and the Wrightstown School District. Please contact the Lawrence Town Office at (920) 336-9131 for information on which school district you reside in.

Q. When is trash and recycling picked up?

A. Trash is picked up at curbside every Monday. The trucks begin their route at 6:00am so it is necessary to have your trash at the curb by that time. All trash must be in trash bags and the provided containers. Recycling items are picked up at curbside every other Monday.

Q. Where do I pay my water bill?

A. Payments are accepted in person or by mail at the Town of Lawrence Business Office at 2400 Shady Ct., De Pere, WI 54115. There is also the option of having your payment automatically deducted out of your bank account. Please contact the office with details. The office accepts cash or checks. Checks can be made out to the Town of Lawrence.

Q. Does the Town accept credit card payments?

A. Unfortunately, the Town of Lawrence does not yet accept payments by credit card.

Q. Where do I get a dog license?

A. The Town of Lawrence has an ordinance requiring the licensing of all dogs. Residents are allowed to have **TWO** dogs at a residence. To obtain a license, residents will need to provide a current rabies certificate from a veterinarian's office, pay an annual fee of \$5.00 for a neutered or spayed dog and \$10.00 for a non-neutered or non-spayed dog. After March 31st, there is a late fee of \$5.00 added on to the license fee. The dog license can be obtained at the Town Business Office during business hours. A dog license expires on December 31 of each year.


A. The Town of Lawrence is your municipality, even though your address is De Pere.

Voter Photo ID Required



Absentee Ballots

You may request an absentee ballot online at https://myvote.wi.gov/. Absentee ballots may also be requested by completing the "Wisconsin Application for Absentee Ballot" by mail or in person. The form can be found at www.gab.wi.gov/forms/gab-121-english or in the clerk's office. The office hours for absentee voting are Monday through Friday 8:00 a.m. until 4:00 p.m.

VOTER Registration Information

If you have had a name change, address change, or you are a new voter in the State of Wisconsin, you will need to complete a new registration form.

A registration form can be completed online at https://myvote.wi.gov/ and filed with the clerk by mail postmarked no later than the 3rd Wednesday before the election. Online registration closed at 11:59 p.m. After the 3rd Wednesday before each election, registrations will need to be completed in person in the clerk's office with proof of residence.



Proof of residence includes the following items:

- 1. A current and valid Wisconsin driver license.
- 2. A current and valid Wisconsin identification card.
- 3. Any other official identification card or license issued by a Wisconsin governmental body or unit.
- 4. Any identification card or license issued by an employer in the normal course of business that contains a photo of the cardholder or license holder, but not including a business card.
- 5. A real estate tax bill or receipt for the current year or the year preceding the date of the election.
- 6. A residential lease which is effective for a period that includes Election Day. (Not for first-time voters registering by mail).
- 7. A university, college or technical college identification card (must include photo) ONLY valid if the voter provides a fee receipt dated within the last 9 months.
- 8. A university, college or technical college identification card (must include photo) ONLY valid if the institution provides a certified housing list to the municipal clerk that indicates citizenship.
- 9. A utility bill (gas, electric, phone, etc.) for the period commencing not earlier than 90 days before Election Day. Statements printed from the internet are acceptable.
- 10. A bank statement. Statements printed from the internet are acceptable.
- 11. A paycheck.
- 12. A check or other document issued by a unit of government.
- 13. An affidavit on public or private social service agency letterhead identifying a homeless voter and describing the individual's residence for voting purposes.

This is not a comprehensive list, but categories for the most common types used by voters.



PUBLIC WORKS

Dumping grass clippings in ditches and vacant lots is prohibited

The Town Yard Waste Facility will accept grass clippings, leaves and garden waste material. There is also an area for branches/brush.



Large pieces of fire wood, rocks, stones, sod, dirt or refuse are not to be dropped off. The facility is available for Town of Lawrence residents only. *Please obtain a window sticker from the Town Office prior to use of the facility.* The Town Yard Waste Facility is located behind the Fire Department. The facility has been recently made larger to accommodate the needs of the Town. Please make sure you follow the signs of where to drop off your yard waste. Other yard materials such as shrubs with a root ball and stumps may be brought to Daanen & Janssen's Quarry located at 1792 Scray Hill Road, De Pere, WI 54115 for a fee. The Yard Waste Facility is monitored by video surveillance cameras.

**The town does not have curbside pickup for brush, leaves or Christmas trees.

GARBAGE

General household waste is not recyclable. Garbage will be collected from each address once weekly. Garbage must be placed at curbside no earlier than 6:00 p.m. the evening before collection, and no later than 6:00 a.m. on your collection day. When placing multiple containers, keep at least four (4) feet between carts.

RECYCLING

Recyclables are collected every other week on your normal garbage day. Recycling carts placed out on the wrong week will not be collected. Recycling must be disposed of in your cart with a blue lid. Placing all accepted recycling items in this one cart is known as



Single Stream Recycling. If you need to replace or request repair on either of your carts, please call the Town at 920-336-9131.

What Should I Do With My Leaves?

Chop your leaves before composting or mulching with a hoe, shovel, or power mower to help them decompose more quickly.


Compost

Leaves make an excellent addition to any compost pile.

Mulch

Leaves are rich in carbon, phosphorus, and potassium — all essential nutrients needed by plants. Spread autumn leaves over your garden and around the bases of bushes, trees, and perennials. During the winter, leaves minimize the alternate freezing and thawing of the soil which often damages plant roots. Pine needles and oak leaves make a good mulch for acid-loving perennials like rhododendrons, lilies of the valley, blackberries, blueberries, raspberries, spruces, yews, butterfly weed and cardinal flowers.

Snowplowing

The Winter season will be here once again. There shall be no overnight parking on any town roads between the hours of 2:00am and 6:00am from November 1 thru March

31. Please remember not to transfer snow from your driveway to the roadway or road right-of-way. You could receive a citation if you place snow from your property onto the roads or right-of-way. If you live near a fire hydrant and are able to shovel around the hydrant, please do so. It would be very much appreciated. The town staff is limited and does not always have the time to get to all the hydrants. Thank you in advance.

Mailboxes: Occasionally during Town snowplowing and snow removal operations, private mailboxes located in the public right-of-way may be damaged or destroyed. If, in the opinion of the Public Works Superintendent, such damage was caused by the actual plow itself rather than by accumulated snow and ice, the Town will reimburse the private property owner up to \$50.00 for the necessary mailbox repairs or replacement. Such reimbursement shall be made to the private property owner upon presentation of the related receipt(s) of the Town Clerk/Treasurer for such mailbox repair or replacement.

Please do not discard your tree at curbside. The trash hauler will not pick up Christmas Trees.



Again this year real Christmas trees will be accepted at the Town Yard Waste Drop-off Facility located at 2400 Shady Court. Please remove all tinsel, wires, ornaments, hooks and tree stands.

<u>Road</u>

ditches are meant to carry water away from roads and adjoining property. During rain events or spring melt, water may fill your ditch and make take a few days or longer to drain away, better in the ditch than in your basement. So please do not alter or plant in road ditches. Do not take it upon yourself to make corrections without contacting the town hall. If you think you have a problem

Information on <u>Stormwater Retention Ponds</u> in the Town of Lawrence

Stormwater retention (wet) ponds are Best Management Practices (BMPs) that hold storm-water runoff and allow the pollutants carried by runoff to settle out. Runoff is conveyed to stormwater ponds by a combination of overland flow, ditches, swales and underground pipes. Stormwater Runoff does not go to a sewage treatment plant. Once runoff reaches a stormwater pond, the sediment settles to the bottom. The water that entered as polluted runoff leaves the pond gradually through an outfall structure, resulting in cleaner water entering the receiving streams, lakes or wetlands. Ponds are also used to reduce the rate of runoff and reduce flooding in urbanized areas.

BENEFITS

- Capable of removing solid particles and other pollutants
- Helps to meet state stormwater management regulations
- Reduces flooding in urbanized areas
- Wildlife habitat is created when ponds are planted with native vegetation and maintained
- Wet ponds can be aesthetically pleasing

RECOMMENDED MAINTENANCE

The ponds in any community may either be public or private, however all ponds need to be maintained. Regular maintenance required of wet ponds may include, but is not limited to:

- Litter/Debris Removal
- Noting erosion of pond banks or bottom
- Inspect for damage to the embankment
- Monitoring for sediment accumulation
- Mowing side slopes
- Monitor Vegetation
- Deter Nuisance Wildlife
- Removal of Sediment
- Examine to ensure that inlet and outlet devices are free of debris and operational

Myth	Reality	
Cattails and other vegetation make ponds unattractive and contribute to their deterioration.	Cattails and other natural vegetation stabilize shorelines, reduce nutrient loads and provide important habitat for non-nuisance wildlife	
Healthy ponds host large populations of ducks and geese.	Ponds with high populations of waterfowl usually have high levels of pollution from their waste. Feeding of ducks/geese is strictly discouraged.	
Stormwater ponds are eyesores that require constant maintenance.	Stormwater ponds can be attractive if managed properly. The amount of maintenance required typically decreases after the first 5 years.	
Stormwater ponds are breeding grounds for disease causing mosquitoes.	Mosquitoes breed in pools of stagnant water. Correctly designed stormwater ponds are designed to minimize stagnant water. Mosquitoes are more commonly found in water sources near homes such as: clogged roof gutters, flowerpots and bird baths.	

WHAT CAN YOU DO?

- Please report odor problems and visible damage to shoreline or slope
- Report signs of invasive species (for detailed information visit NEWWaterWisconsin.org)
- Report excessive algae growth, which may be caused by nutrients from fertilization practices
- Please do not dump anything into the pond, especially aquatic pets. This
 is prohibited by your local municipality, State and Federal Government,
 unless the appropriate permits are obtained.
- We want all citizens to be aware of the purpose of our storm ponds as an important water treatment facility, and to avoid any activity, use or action in pond reas that negatively impacts this intended function of storm ponds.

During the week of <u>October 22nd-26th, 2018</u> the Wisconsin Department of Justice (DOJ) in conjunction with the Hobart/ Lawrence Police Department and the Drug Enforcement Administration (DEA) coordinated a Prescription Drug Take Back Initiative throughout Wisconsin. The focus was on removing potentially dangerous pharmaceutical substances from our state's medicine cabinets and preventing them from going into our water supply.


This week long effort continued to bring focus to the issue of pharmaceutical controlled substance abuse. This was a great opportunity for law enforcement agencies to host a take back event, and/or safely dispose of medications collected in prescription drug drop boxes. No businesses were allowed. All waste pharmaceuticals must have been generated by a household.

The Prescription Drug Take-Back goal was to provide a safe, convenient, and responsible means of disposal, while also educating the general public about the potential for abuse of these medications. Unused or expired medicine should never be flushed or poured down the drain. Water reclamation facilities are not designed to remove all of them and trace amounts of pharmaceuticals are showing up in rivers and lakes around the world.

Participants were able to dispose of solid, non-liquid medication(s) by removing the medication from its container and disposing of it directly into a disposal box or into a clear sealable plastic bag. Plastic pill containers should not be collected. It is recommended that recycling bins are provided at the collection sites for disposal of such containers. Blister packages are acceptable without the medications being removed. Thank you for your help with this important initiative.

Fire Department



With the summer season drawing to a close and we all start to do our fall clean up, the Lawrence Fire Dept. would like remind our residents and businesses of a couple very important safety tips.

We usually don't give our address a second thought when pulling into our driveway. But one of the best things you can do to easily be located during an emergency is to make sure your house number is able to be quickly identified by emergency responders. Make sure landscaping is cut back along the house, the numbers are not faded or missing, and most importantly, make certain the numbers are large enough to be easily read from the road. If you live on a long driveway, ensure the house numbers are posted somepalce near the end of the driveway.




As the temperature dips down and frost starts to form on the pumpkins, the heating season is upon us. We remind everyone to have all your heating appliances serviced and checked by a licensed professional to



make sure they are operating as intended. Place a CO detector on each floor of your home, much like smoke detectors. If you feel there is an issue in your home or your CO detector sounds, do not hesitate or delay calling the fire department.

Carbon Monoxide is a colorless, odorless, and tasteless gas which is the number one cause of accidental poisoning deaths in the United States. Carbon Monoxide gas is nearly impossible to identify without a CO detector, and even though CO detectors have become common in homes and apartments, CO poisoning still causes about 15,000 emergency room visits and 500 deaths each year.



*** We would like to remind our residents and business that in the event you need the Fire Department or an Ambulance, to please call 911. Even though you don't feel it is an emergency, 911 is the fastest and most efficient way for us to provide services to you. The non-emergency number to call is 920-391-7450. Calling the Town Hall may create a delayed response to something that truly is an emergency. ***

Building Inspections and Permits

Before beginning projects around your home, please make sure you apply for a building permit. Building permits are required per ordinance for projects such as: swimming pools, fences, basement remodels, sheds, and decks. ** When doing projects, please be aware of your property lines and of any easements (utility, drainage, access easements) located on your property.**

A Note for Homeowners

Per Town Ordinance 116-26, homeowners are required to complete landscaping within 9 months of occupancy. Erosion control is required to prevent materials from leaving the constructions site and creating problems for storm water management.

Example of acceptable erosion control:



Silt sock is used to prevent materials from leaving the site which help contain costs for the Town regarding stormwater ponds.

- **Minimum 1.5" Stone Tracking Pad Required
- **Silt Fence or Silt Sock Required
- **Protect Inlets, Ditches, Streets, and Swales
- **Straw or Mulch new lawns

Final Grade and Landscaping must comply with all Drainage Plans drafted for the Development and surrounding areas!

Example of <u>unacceptable</u> erosion control:

Improper erosion control results in materials in the street and in storm drains as well as sediment on the roads.
